OTHER CORNER DESCRIPTIONS
AND SUPPLEMENTAL DATA

The cor. of secs. 25 and 36, T. 3 S., R. 56 E., and secs. 30 and 31, T. 3 S., R. 57 E., Mt. Diablo Mer., was found monumented with a granite rock, 16 x 16 ins. x 4 ins. above ground, mkd. with 5 notches on the north face, and 1 notch on the south face, with a 5½ ft. steel fence post.

U.S.M.M. No. 326 was found monumented with a brass cap mkd. U.S.M.M. 326, with 3/32 ins. diam. hole, set in an iron pipe, 2 ins. diam., 16 ins. above a pyramidal concrete base, and 3.0 ft. above the base rock. The pyramidal base is 17 x 17 ins. at the base and 8 x 8 ins. at the top, from which 2 bearing objects were found;

A north tilting rock 84.8 ft. dist., mkd. BRUSMM 326 on south face, and an X on highest point, as witnessed in the official record.

A south tilting rock, 127.0 ft. dist., mkd. with apparent scribing, too weathered to read, as witnessed in the official record.

The cor. of secs. 25 and 36, T. 3 S., R. 56 E., and secs. 30 and 31, T. 3 S., R. 57 E., Mt. Diablo Mer., described above, bears N. 55°54'45" W., 1,442.00 ft. dist. from U.S.M.M. No. 326 described above.

M.S. No. 4760 Scheelite No. 1 lode: Cor. No. 1 is monumented with a badly weathered post mkd. M.S. 4760. Cor. Nos. 3 and 4 are monumented with posts with no observable markings. Cor. No. 2 is obliterated. Cor. No. 2 was re-established by record bearing and dist. from 2 found bearing trees, as witnessed in the field notes for M.S. No. 4760. Line 1-2 was thus found to be S. 57°31'36" W., 194.84 ft. from Cor. No. 1 to Cor. No. 3, M.S. 4760 Scheelite lode, thence S. 57°39'19" W., 471.47 ft. to Cor. No. 2, Scheelite No. 1 lode, instead of S. 57°33'30" W., 666.30 ft. as approved. Line 2-3 was found to be S. 6°42'15" E., 1,475.68 ft., instead of S. 6°39'30" E., 1,475.00 ft. as approved. Line 3-4 was found to be N. 57°37'04" E., 666.31 ft., instead of N. 57°33'30" E., 666.3 ft. as approved.

M.S. No. 4760 Townsite No. 2 lode: Cor. No. 2 is a 6 x 6 ins. post, in a mound of rocks, mkd. T2-2-4760. Cor. No. 3 is a limestone outcrop mkd. X-T2-3-4760. Cor. Nos. 1 and 4 are lost. Line 2-3 was found to be S. 12°54'19" E., 1,501.37 ft., instead of S. 12°55' E., 1,500.00 ft. as approved. Cor. No. 2 was remonumented with an iron post, 24 ins. long, 2 ins. diam., 18 ins. in the ground, with a brass cap mkd. T2-2-4760; from which
