CHAINS

These field notes are those of the remonumentation of a corner of the survey executed by T.A Haigh, U.S. Surveyor, and H.W. Reppert, U.S. Transitman, in 1912.

The cor. of secs. 29, 30, 31 and 32, monumented with the bottom portion of an iron post, 2 ins. diam., rusted off flush with the ground, alongside of which is lying the top portion of the iron post, 18 ins. long, with brass cap mkd. "T24N R34E S29 S30 S31 S32 1912" with a mound of stone W. of cor. This corner will now refer to the cor. of secs. 29 and 30 only.

At the corner point

Set a stainless steel post, 28 ins. long, $2\ 1/2$ ins. diam., 24 ins. in the ground, over a plastic-encased magnet, with brass cap mkd.

T24N R34E S 30 S 29 S 31

Insert the piece of the original iron post with the brass cap inside the stainless steel post, deposit pieces of the iron post alongside the stainless steel post, destroy the mound of stone W. of cor., and build a mound of stone, 3 ft. base, 2 ft. high, N. of cor.
