CHAINS These field notes are those of the remonumentation of a corner of the survey executed by T. A. Haigh, U.S. Surveyor and H. W. Reppert, U.S. Transitman, in 1912. The cor. of secs. 23, 24, 25 and 26, monumented with the remains of the bottom portion of an iron post, 16 ins. long, 2 ins. diam., and filled with concrete, firmly set, 6 ins. below the surface of the ground. At the corner point Set a stainless steel post, 28 ins. long, 2 1/2 ins. diam., 24 ins. in the ground, over a plastic-encased magnet, with brass cap mkd. T26N R30E S23 S24 S26 S25 2007 Bury remains of the original iron post alongside the stainless steel post. Cor. is located 1 ft. N. of Nevada Department of Transportation wood post and 5 ft. W. of a N-S powerline.
