CHAINS

The following field notes are those of the dependent resurvey of a portion of the subdivisional lines, Township 7 South, Range 56 East, Mount Diablo Meridian, Nevada.

History of GLO/BLM Surveys:

- 1869: E.B. Monroe, U.S. Deputy Surveyor, surveyed the west boundary (Ruby Valley Guide Meridian), under Contract No. 31.
- 1965: E.W. Sibley, Cadastral Surveyor, surveyed the east boundary, under Group No. 430.
- 1977: R.A. Pratt, Cadastral Surveyor, resurveyed a portion of the west boundary (Ruby Valley Guide Meridian) and surveyed the south boundary, under Group No. 548.
- 1988: R.A. Pratt, Cadastral Surveyor, surveyed a portion of the subdivisional lines and the north boundary of section 1, under Group No. 667.
- 1995: R.E. Williams, Cadastral Surveyor, surveyed a portion of the subdivisional lines and subdivided sections 13 and 24, under Group No. 754.

Before restoring the corners, the lines of the original surveys were retraced and a diligent search made for any evidence of the position of the original corners and other calls of the original field note record.

The survey was executed in accordance with the specifications set forth in the <u>Manual of Surveying Instructions</u>, 2009 edition, and the Special Instructions for Group No. 980, Nevada, dated March 6, 2018.

Measurements were made with Trimble R-10 Global Positioning System (GPS) receivers using the real-time kinematic (RTK) method. All reported positions and measurements are referenced to the NAD 83 (2011) (EPOCH: 2010.0000) datum. All bearings refer to the true meridian based on geodetic methods and are reported as mean bearings. The distances are reported as horizontal measurements.

The geographic position of the following corners was determined from GPS static observations processed by National Geodetic Survey, Online Positioning User Service (OPUS), utilizing Continuous Operation Reference Stations (CORS) NVTP TROPICANA CORS ARP, NVWS WARM SPRINGS CORS ARP AND NVPI PIOCHE CORS ARP, and carried forward by RTK observations.

The cor. of secs. 11, 12, 13 and 14 is as follows:

The March 8, 2018 mean magnetic declination was determined to be 12° E., as obtained from the National Oceanic and Atmospheric Administration's National Centers for Environmental Information declination calculator.

Reestablishment of a Portion of the Survey Executed by R.A. Pratt, Cadastral Surveyor, in 1988

Beginning at the cor. of secs. 11, 12, 13 and 14, monumented with a stainless steel post, 2 1/2 ins. diam., firmly set, projecting 5 ins. above ground, in a scattered mound of stone, with brass cap mkd. as described in the field notes of the 1988 survey of a portion of the subdivisional lines, executed under Group No. 667.

Alongside a steel fence post, projecting 3.8 ft. above ground, with a U.S. Air Force Installation Warning sign, and Land Survey Monument sign, attached.

Cor. is located on gentle westerly slope amongst sage brush and Joshua trees.

Cor. is located on level ground, south of Groom Road, amongst sage brush and Joshua trees.
