Land, mountainous. Soil, gravelly and rocky; 4th rate.

Undergrowth, creosote brush, sage and cacti.

Return to the stan. cor. of secs. 31 and 32.

Thence, east on a random line on S. bdy. sec. 32.

- 40.30 A point 12 lks. N. of the stan. $\frac{1}{4}$ sec. cor.

- 79.72 A point 16 lks. N. of the stan. cor. of secs. 32 and 33, which is a granite stone, 16x14x10 ins. above ground, set in a mound of stone 3 ft. base and 1 ft. high and marked with 4 notches on E. and 2 notches on W. sides. In place of stone cor., which is set alongside,

Set an iron post 3 ft. long 2 ins. diam., 16 ins. in the ground to bedrock, and rebuild the mound of stone around post to top, for stan. cor. of secs. 32 and 33, with brass cap marked
