chains	Over rolling land, thru scattering undergrowth.
	Descend 55 ft. over rocky washland, drains SW.
12.00	Foot of rocky hills, bears N. and SW.; ascend 100 ft.
14.50	Rocky point, slopes SE.; continue over broken S. slope.
34.50	Saddle in a spur, slopes SW.; descend 125 ft.
40.18	The orig. $\frac{1}{4}$ sec. cor., which is a stone 15x12x8 ins. above ground, set in a mound of stone 3 ft. base and 1 ft. high and mkd. $\frac{1}{4}$ on N. side. At point for cor. is a stone 15x12x8 ins. base and 1 ft. high and mkd. $\frac{1}{4}$ on N. side. Set an iron post 3 ft. long 1 in. diam., 20 ins. in the ground to bedrock, with the original stone corner set alongside, and in a mound of stone to top, for $\frac{1}{4}$ sec. cor., with brass cap marked

9.80 A wash, 40 lks. wide, course SW.; ascend 115 ft.
19.20 Change to broken SW. slope; descend 100 ft.
37.50 A ridge-spur, slopes SW.; descend 30 ft. on NW. slope.
39.97 The cor. of Ts. 27 and 28 S., Rs. 59 and 60 E.  Land, rolling, hilly and mountainous. Soil, gravelly, 3d rate; rocky, 4th rate. Undergrowth, creosote brush, sage and cacti.

South, on a random line bet. secs. 1 and 6.

31.73	Intersect the California-Nevada State Boundary.
40.12	A point 33 lks. E. of the orig. $\frac{1}{4}$ sec. cor., which is a malpais stone, 22x15x15 ins. above ground, set in a mound of stone 4 ft. base and 1 ft. high and marked $\frac{1}{4}$ on W. side. As this corner no longer serves a useful purpose I destroy all evidence of same.
62.46	Record distance; find no trace of closing cor. of frac. T. 28 S., Rs. 59 and 60 E.
80.69	A point 80 lks. E. of an unofficial cor. of secs. 1, 6, 7 and 12, which is a mound of stone 4 ft. base and 2 ft. high, with remains of a decayed mesquite stake.  From this cor., an unofficial closing cor. of secs. 7 and 12 bears south, 5.29 chs. dist.; a mound of stone 3 ft. base and 1 ft. high.  I destroy all evidence of both these corners.
