From this point:

Monument 122 on the California-Nevada boundary bears S.46°05'E., 4.14 chs. dist.; described in the field notes of the Portion of the California-Nevada State Boundary resurveyed under this group.

The orig. clos. cor. of T. 26 S., Rs. 57 and 58 E., on the Von Schmidt California-Nevada state line, bears S.2°30'E., 4.72 chs. dist.; a mesquite stake, 3 ins. sq., 3 ft. above a mound of stone 2 ft. base and 1 ft. high; and marked TXXVIS on N., RLVIIIE SVI on E., RLVIIIESI on W. and CC on S. sides. I obliterate all evidence of this orig. cor.

Land, desert washland.

Soil, gravelly, 3d rate; and rocky, 4th rate.

Undergrowth, creosote brush and cacti.

N.45°31'W., on a random line on 551st mile.

**52.44** A point 7 lks. NE. of the point of an unofficial clos. cor. of secs. 2 and 35, Ts. 26 and 27 S., R. 58 E., hereinbefore described; and cor. destroyed.

**80.12** A point 14 lks. SW. of the 550 mile cor.; a mesquite stake, 2 ins. sq., 3 ft. above a mound of stone and earth, 5 ft. base and 2 ft. high; marked as described in the official record.

I obliterate all evidence of this corner.

Thence, from point for cor.

N.45°28'W., on a random line on 550th mile.

**36.59** A point 42 lks. SW. of an unmarked limestone, 20x20x16 ins., set in a mound of stone 3 ft. base and 2 ft. high.
