36.99	A point 3.56 chs. E. of the orig. $\frac{1}{4}$ sec. cor.
40.10	A point 3.55 chs. E. of the orig. clos. cor. of frac. T. 23 S., Rs. 54 and 55 E.
0.00	Return to the cor. of Ts. 22 and 23 S., Rs. 54 and 55 E.
.94	Thence, S. $5^{\circ}30'W.$ , on true line bet. secs. 1 and 6.
5.00	Over nearly level desert land, thru medium dense under-growth.
19.00	A wash, 1 ch. wide and 20 ft. deep, course SW.
✓37.16	The orig. $\frac{1}{4}$ sec. cor.; a stone, 12x8x4 ins., lying on a mound of earth and marked $\frac{1}{4}$ on top side, witnessed by pits E. and W., about 5 ft. dist.
	At point for cor. 1933
	Set an iron post 3 ft. long 1 in. diam., 30 ins. in the ground, with the orig. stone cor. deposited at the base, for $\frac{1}{4}$ sec. cor., with brass cap mkd.
	Thence, S. $0^{\circ}18'E.$ , on true line bet. secs. 1 and 6.
2.87	Intersect the Von Schmidt California-Nevada line.
	Set an iron post 3 ft. long 1 in. diam., 30 ins. in the ground, with a rock, 12x8x6 ins., mkd. X, deposited at the base, for closing cor. of T. 23 S., Rs. 54 and 55 E., with brass cap mkd.
	raise a mound of stone 2 ft. base and 1 $\frac{1}{2}$ ft. high N. of cor.
	From this point the angle point at point for orig. 517 mile cor. on the Von Schmidt boundary bears S. $44^{\circ}03'E.$ , 48.27 chs. dist., hereinbefore described.
	Thence, south on true line bet. secs. 1 and 6.
.24	A point 1/8 lks. W. of the orig. clos. cor. of frac. T. 23 S., Rs. 54 and 55 E.; a limestone, 10x8x5 ins., lying on a mound of earth and marked CC on top. I destroy all evidence of this corner.
35.35	A road, bears E. and SW.; not in present use.
40.60	A point west of the cor. of secs. 5, 6, 7 and 8, hereinafter described.
	Set an iron post 3 ft. long 3 ins. diam., 30 ins. in the ground, with charcoal deposited at the base, for cor. of secs. 1, 6, 7 and 12, with brass cap mkd.
