

Resurvey of Subdivision T.25 N., R. 18 E.

79.32	<p>the same stone at the same point, 12 ins. in the ground for the $\frac{1}{4}$ sec. cor. to secs. 19 and 24. The falling for the distance run makes the course of the line from the cor. of secs. 19, 24, 25 and 30, to the $\frac{1}{4}$ sec. cor. to be N.0°35'E. I continue retracing North from the $\frac{1}{4}$ sec. cor. to secs. 19 and 24. At this point I find the cor. to secs. 13, 18, 19 and 24, falling 68 lks. east of my line. It is a basalt stone 14x8x5 ins., set in a mound of stone and marked with 3 notches on the N. and S. edges. I destroy the mound of stone in which it is set and set the same stone at the same point 11 ins. in the ground for the cor. to secs. 13, 18, 19 and 24, and raise a mound of stone 2 ft. base, 1$\frac{1}{2}$ ft. high, W. of cor. The falling for the distance run makes the course of the line from the $\frac{1}{4}$ sec. cor. to the cor. of secs. 13, 18, 19 and 24 to be N.0°58'E.</p>
40.00 80.90	<p>RESURVEY OF SUBDIVISION IN T.25 N., R.18 E.</p> <p>From the cor. of secs. 13, 18, 19 and 24, on the E. Bdy. of the township, I run West on a blank line retracing the line between secs. 13 and 24. At this point I search diligently but find no $\frac{1}{4}$ sec. cor. At this point I find the cor. of secs. 13, 14, 23 and 24, falling 40 lks. N. of my line. It is a juniper stake 2 ft. long, 2 ins. dia., firmly set in the ground in a mound of earth and stone, but so badly decayed that the markings are undecipherable.</p>
40.20	<p>From the cor. of secs. 13, 14, 23 and 24, I run South on a blank line retracing the line between secs. 23 and 24. At this point I find the $\frac{1}{4}$ sec. cor., falling 41 lks. W. of my line. It is a granite stone 12x7x5 ins. lying on the ground on a mound of earth and marked $\frac{1}{4}$.</p>
45.10	<p>I return to the cor. of secs. 13, 14, 23 and 24, and run north on a blank line retracing the line between secs. 13 and 14. At this point, I find the $\frac{1}{4}$ sec. cor., falling 72 lks. E. of my line. It is a granite stone 11x5 ins. by 5 ins. above ground, firmly set and marked $\frac{1}{4}$ on the W. face. There are no accessories.</p>
87.52	<p>I continue my blank line North. At this point I find the cor. of secs. 11, 12, 13 and 14, falling 2.00 chs. E. of my line. It is a basalt rock in place 24x18 ins. by 16 ins. above ground, marked with a X at corner point and with 4 notches on S. and 1 notch on E. edge. There were no accessories.</p>
	<p>I now return to the cor. of secs. 13, 18, 19 and 24 on the E. Bdy. of the township, and resurvey as follows: N.89°43'W. on a true line between secs. 13 and 24.</p>
