2. Resurvey of portion of 6th Standard Parallel North thru R.57 E.

Chains October 29, 1915: At Standard cor. of secs. 33 and 34, hereinafter described, I set off 13°16'S. on the decl. arc: and observe the sun at apparent noon. The resulting latitude is 40°33'N. E. on retracement along S. bdy. sec. 34.
Ascending over steep S.W. slope of mountain, over series of cliffs from 10 to 300 ft. high.
Find no evidence of Witness Corner. 40.00 Impossible to continue this line further owing to vertical 60.83 cliffs 200 ft. high extending N.CO-W. and D.CO-L. For the same reason it is impossible to offset or triangulate because it is impossible to measure the base line. Therefore, I run N.47°30'E. 4.99 chs. through a gap in cliff. Thence, along ledge, N.57°E., 2.97 chs. cliffs 200 ft. high extending N.80°W. and S.80°E. gap in cliff. Thence, along ledge, N.57°E., 2.97 chs. to top of cliff. This point is 4.99 chs. Continue E. along S. bdy. of sec. 36. No evidence of $\frac{1}{4}$ sec. cor. Old cor. of Tps. 31 N., Rs. 57 and 58 E., which bears 40.00 74.98 S. 118 lks. A pine post 24x2x2 ins. standing in a mound of stone marked with 6 notches on each corner. Course of line from secs. 33 and 34 to above township corner S.89°43'E. Length 234.98 chs. October 30, 1915. RESURVEY OF PORTION OF 6th STANDARD PARALLEL NORTH, THROUGH RANGE 57 EAST. Nov. 13, 1915. From the Standard corner of secs. 33 and 34, hereinafter described, I, run S.89°43'E. on resurvey of S. bdy. of sec. 34.
Ascending over steep SW. slope of mountain, over a series of cliffs, ranging in height from 10 to 300 ft. high. Enter dense and heavy sage and choke cherry brush. Set an iron post 3 ft. long, 1 in. diam., 26 ins. in the ground for Standard 4 sec. cor., with brass cap mkd: 30.20 40.00
