21.00 Ravine, 20 ft. below ridge, course NW., asc.
 31.50 Ridge, 35 ft. above ravine, bears NE. and SW., desc.
 40.00 Swale, 30 ft. below ridge, course W., asc.
 Set an iron post 3 ft. long, 1 in. in dia., 26 ins. in the ground for the $\frac{1}{4}$ sec. cor. of secs. 4 and 5, with brass cap mkd:

$\frac{1}{4}$ S5 | S4

and raise a mound of stone 2 ft. base, $1\frac{1}{2}$ ft. high, W. of cor.

44.00 Ridge, 20 ft. above $\frac{1}{4}$ sec. cor., bears E. and W., desc.
 57.00 Wash, 14 ins. deep, 20 lks. wide, in Bob Canyon, 160 ft. below ridge, course SW., asc.
 72.00 Ridge, 175 ft. above Bob Canyon, bears NW. and SE., desc.
 79.00 Rayine, 50 ft. below ridge, course SW., asc.
 89.93 Intersect N. Bdy. of Tp., falling 13.84 chs. N.89°51'W. of the cor. of secs. 32 and 33, heretofore described.

Set an iron post 3 ft. long, 2 ins. in dia., in a mound of stone for the Closing Corner of Secs. 4 and 5, with brass cap mkd:

and raise a mound of stone 2 ft. base, $1\frac{1}{2}$ ft. high, S. of cor.

Note: On account of natural obstacles I am unable to set the post in the ground.

Undergrowth, dense sagebrush, good grass for grazing.

November 28:

At 8 h 0 m, a.m., l.m.t., I set off 40°33' on the lat. arc; 21°09'S. on the decl. arc; and determine a meridian with the solar at the cor. of secs. 29, 30, 31 and 32.

Thence N.0°03'W. between secs. 29 and 30.

Ascend gently across broad ridge, thru dense sagebrush.

9.50 Top of ascent, bears N.80°E. and S.80°W., 20 ft. above sec. cor.

17.50 Head of hollow, 20 ft. below top of ascent, course S.60°W. ascend gently.

40.00 Set an iron post 3 ft. long, 1 in. in dia., 20 ins. in the ground and in a mound of stone for the $\frac{1}{4}$ sec. cor. of secs. 29 and 30, with brass cap mkd:

$\frac{1}{4}$ S30 | S29
 1914

and raise a mound of stone 2 ft. base, $1\frac{1}{2}$ ft. high, W. of cor.

Note: On account of natural obstacles I am unable to set the post more than 20 ins. in the ground.

43.00 Begin ascent of ridge, bears N.80°E. and S.80°W.

72.80 Ridge, 300 ft. above $\frac{1}{4}$ sec. cor., bears E. and W., desc.

80.00 150 ft. below ridge.
