Thence I run
N. 89°00' E.
42.39 Mountain spur, slopes SE. 70 ft. above corner.
44.81 Draw, course SE. Ascend.
47.31 Mountain spur, slopes S. 25 ft. above draw.
Descend steep SE. slope.
54.24 Foot of slope, 190 ft. below spur; thence along N. side
of ravine, descending gradually.
65.27 55 ft. below foot of slope. The old Standard Cor. for
the S.E. cor. of T. 31 N., R. 51 E. I destroy all
trace of this corner and its accessories and reestablish
it at the same point as follows:
Set an iron post 3 ft. long, 3 ins. in dia., 24 ins.
in the ground for the Standard S.E. Cor. of T. 31 N.,
R. 51 E., with brass cap mkd:

Good growth of sagebrush, fair grass, no timber.
Good grazing land.

July 31, 1915.

At the cor. of secs. 19, 24, 25 and 30, on the
west bdy. of the township, at 8 h 0 m a.m., l.m.t., I
set off 40°25' N. on the lat. arc, 18°27' N. on the decl.
arc, and determine a meridian with the solar.

East between secs. 19 and 30.

37.25 Search diligently but find no trace of the $\frac{1}{4}$ sec. cor.
77.25 Search diligently but find no trace of the cor. of
secs. 19, 20, 29 and 30. I set a temporary corner.

East on retracement between secs. 20 and 29.

40.00 Search diligently but find no trace of $\frac{1}{4}$ sec. cor.
80.00 Search diligently but find no trace of the cor. of
secs. 20, 21, 28 and 29. I set a temporary corner.
It was cloudy at noon and observation for latitude
was impossible.

From the temporary cor. of secs. 20, 21, 28 and 29,
I retrace

North between secs. 20 and 21.

40.00 Search diligently but find no trace of $\frac{1}{4}$ sec. cor.
80.00 Search diligently but find no trace of the cor. of
secs. 16, 17, 20 and 21. I set a temporary corner.

North on a retracement between secs. 16 and 17.

8, 9, 16 and 17.
I set a temporary corner.
