## GENERAL DESCRIPTION.

This fractional township is made up of rolling hills, low ridges, and shallow ravines and washes, all with a general SE. slope.

The soil is a sandy, medium texture desert loam, derived from the disintegration of sedimentary rocks, varying in depth from a few inches on the hill slopes to several feet in the bottoms of the draws. It is a good quality soil, but too dry to raise crops without irrigation, and it does not seem possible to get water from any source to irrigate it.

It is a very fair grazing country, there being a good growth of sagebrush and considerable grass, weeds and other browse. It, and the surrounding country is poorly watered, though, there being no water in this fractional township.

There are no settlers. There is no land in cultivation in this fractional township nor any in cultivation nearby.

There is no timber.
