Chains
79.00 Ridge, bears E. and W. descend slightly to top of rim-rock.
82.20 Rim-rock, 15 ft. high, facing N. 10°E. bears N. 80°W. and S. 80°E.
82.37 Intersect N. bdy. of Tp. at a point 11.73 chs. West of the cor. of secs. 31 and 32, and at point of intersection set an iron post, 3 ft. long, 2 ins. in diam. securely rocked in between two large rocks for CC of secs. 5 and 6, with brass cap marked

and raise a mound of stone, 2 ft. base, 1½ ft. high S. of corner.
