Note: No change of the course or the topography of this boundary was found with that given in the official record of the survey of T. 41 N., R. 22 E., Group 122, Nevada.

From the standard cor. of T. 41 N., Rs. 21 and 22 E., heretofore described.

N. $0^{\circ}25'$ W., on a retracement line along the E. bdy of sec. 36, T. 41 N., R. 21 E.

27.79 Intersect the cor. of secs. 30 and 31, T. 41 N., R. 22 E., which is an iron post, 2 ins. diam., with brass cap, set, marked and witnessed as described in the official record, of the survey of T. 41 N., R. 22 E.

40.03 Intersect the $\frac{1}{4}$ sec. cor. of sec. 36, T. 41 N., R. 21 E., which is an iron post, 1 in. diam., with brass cap, set, marked and witnessed as described in the official record of the survey of T. 41 N., R. 22 E.

I change the date on this post from 1927 to 1932.

Thence

N. $0^{\circ}28'$ E., with continuous measurement.

67.83 Intersect the $\frac{1}{4}$ sec. cor. of sec. 30, T. 41 N., R. 22 E., which is an iron post, 1 in. diam., with brass cap, set, marked and witnessed as described in the official record of the survey of T. 41 N., R. 22 E.

79.38 Intersect the cor. originally for secs. 25 and 36, T. 41 N., R. 21 E., and which was changed to an angle point as described on page 21 of these notes.
Thence, N. $5^{\circ}59'$ E., with continuous measurement.

80.00 The cor. of secs. 25 and 36, T. 41 N., R. 21 E., which is described on page 21 of these notes.

N. $5^{\circ}59'$ E., along the E. bdy. of sec. 25.

27.98 The cor. of secs. 19 and 30, T. 41 N., R. 22 E., which is an iron post, 2 ins. diam., with brass cap, set, marked and witnessed as described in the official record of the survey of T. 41 N., R. 22 E.

36.43 The $\frac{1}{4}$ sec. cor. of sec. 25, T. 41 N., R. 21 E., which is an iron post, 1 in. diam., with brass cap, set, marked and witnessed as described in the official record of the survey of T. 41 N., R. 22 E.
