

SUBDIVISION OF T. 8 $\frac{1}{2}$  S., R. 70 E.

## Chains

From the cor. of secs. 1, 2, 35 and 36, on S. bdy of Tp. described in the field notes of T. 9 S., R. 70 E., surveyed under this assignment.

N. 0° 01' W., bet. secs. 35 and 36.

Over rolling desert land, thru low brush and scattering joshua.

Ascend 15 ft. over S. slope.

2.00 Spur, slopes SE., desc. 50 ft. over N. slope.

7.00 Over rolling land, slopes E.

25.70 Side wash, 20 lks. wide, drains SE.; ascend 40 ft.

40.00 Point for the  $\frac{1}{4}$  sec. cor. of secs. 35 and 36.

Set an iron post, 30 ins. long, 2 $\frac{1}{2}$  ins. diam., 26 ins. in the ground, with brass cap mkd.

raise a mound of stone, 2 $\frac{1}{2}$  ft. base, 2 ft. high, W. of cor.

61.88 Intersect the Second Standard Parallel South.

Point for the closing cor. of secs. 35 and 36.

Set an iron post, 30 ins. long, 2 ins. diam., 24 ins. in the ground, with brass cap mkd.

raise a mound of stone, 3 ft. base, 2 ft. high, S. of cor.

From point of intersection the standard cor. of secs. 35 and 36, T. 8 S., R. 70 E., bears E., 17.34 chs. dist., described in the field notes of the portion of the 2d stan. par. S., resurveyed under this assignment.

Land, rolling.

Soil, sand, rock and gravel.

Undergrowth, greasewood and cacti, sage and black brush.

Timber, Joshua trees.

At midpoint on the N. bdy. of sec. 36.

Point for the  $\frac{1}{4}$  sec. cor. of sec. 36.

Set an iron post, 30 ins. long, 2 ins. diam., 24 ins. in the ground, with brass cap mkd.

raise a mound of stone, 3 ft. base, 2 ft. high, S. of cor.

From this point the stan.  $\frac{1}{4}$  sec. cor. on S. bdy. of sec. 36, bears E., 17.32 chs. dist.
