

## INDEPENDENT RESURVEY OF SUBDIVISION OF T. 25 S., R. 63 E.

## Chains

Land, nearly level desert, with gentle northwesterly slope.  
 Soil, sandy; 3rd rate.  
 Timber, none.  
 Undergrowth, creosote brush and cactus; scattered growth of weeds and grass.  
 Grazing, poor.

At midpoint on the N. bdy. of sec. 5,

Set an iron post, 3 ft. long, 1 in. diam., 27 ins. in the ground, for  $\frac{1}{4}$  sec. cor. of sec. 5 only, with brass cap marked

From this corner, the standard  $\frac{1}{4}$  sec. cor. of sec. 32, T. 24 S., R. 63 E., bears West, 5.03 chs. dist; an iron post, 1 in. diam., firmly set, marked and witnessed as described in the official record.

At point on the N. bdy. of sec. 6, 40.00 chs. W. of the closing cor. of secs. 5 and 6,

Set an iron post, 3 ft. long, 1 in. diam., 30 ins. in the ground, for  $\frac{1}{4}$  sec. cor. of sec. 6 only, with brass cap marked

## GENERAL DESCRIPTION

Township 25 South, Range 63 East, is located along U. S. Highway No. 95, between Las Vegas and Searchlight, Nev., approximately 30 miles from Las Vegas, and 20 miles north of Searchlight, and is about 15 miles southwesterly from Boulder Dam. The oiled surface highway passes through the central portion of the township.

The land within the township is desert, with hills in the eastern portion, opening into a wide valley bottom toward the west. The elevation above sea level, as given on the U. S. Geological Survey topographic map, varies from about 1800 ft. in the extreme northwest portion, to about 3800 ft. in the hills of the southeastern portion of the township; the general drainage and exposure being northwesterly into a dry lake bed.

The soil is rocky and shallow, 4th rate in the hills; and gravelly and sandy, 3rd rate, in the valley.

There is no timber within the township. The vegetation consists chiefly of creosote brush, cactus, yucca, cat claw, sagebrush, rabbit brush, weeds and grass.

The area is poor grazing land, and at the time of this resurvey no livestock were being grazed within the township.
