## Dependent Resurvey, South Boundary of Section 32, T. 20 N., R. 18 E.

## Chains

- 18.65 Draw, drains S.; asc. 265 ft. over abrupt E. slope.
- 27.90 Change to S. slope; asc. and desc. along same.
- 34.30 Spur, slopes S.; desc. 80 ft. over SW. slope.
- 38.25 Draw, drains S.; asc. 45 ft. over SE. slope to  $\frac{1}{4}$  sec. cor.
- 40.26 Point for the  $\frac{1}{4}$  sec. cor. of secs. 5 and 32, at proportionate distance; there is no remaining evidence of the original corner.
- Set a granite stone, 6 x 8 x 30 ins., 20 ins. in the ground, and in a flat mound of stone, 4 ft. diam., mkd. on top face, X  $\frac{1}{4}$ .
- from which
- A yellow pine, 12 ins. diam., bears N.  $25\frac{1}{2}^{\circ}$  E., 61 lks. dist., mkd.  $\frac{1}{4}$  S32 BT.
- A yellow pine, 6 ins. diam., bears S.  $12^{\circ}$  E., 39 lks. dist., mkd.  $\frac{1}{4}$  S5 BT.
- Asc. 35 ft. over SE. slope.
- 43.85 Spur, slopes S.; thence over a series of rocky points projecting to the south.
- 80.52 The cor. of secs. 5, 6, 31 and 32, monumented with an iron post, 2 ins. diam., firmly set, marked and witnessed as described in the official record of the resurvey of the south boundary of section 31, executed in 1918 under Group 35, California, in connection with the resurvey of the California-Nevada State Line.
- Land, mountainous.  
Soil, clay and gravel.  
Timber, scattering pine and fir.  
Undergrowth, sage and other low shrubs.

## Remonumentation of the Sec. Cors. of Sec. 22, T. 20 N., R. 18 E.

Reestablishment of Corners Originally Established by  
Solomon W. Foreman, Deputy Surveyor, in 1865.

The cor. of secs. 22, 23, 26 and 27, marked by an iron stone, 10 x 12 x 22 ins., marked with 2 grooves on S. and 2 grooves on E. faces, and set in an old mound of earth and stone.

At the corner point

Set an iron post, 3 ft. long, 2 ins. diam., 26 ins. in the ground and in a mound of stone, 4 ft. base, 12 ins. high, with brass cap mkd.
