Township 11 North, Range 29 East, is situated about 23 miles north of Hawthorne, Nevada. The terrain is level to gentle sloping. The elevation varies from 3,950 to 4,000 feet above mean sea level. The soil varies from sand and gravel along the lake shore to alkaline silt along the river. The vegetation consists of shadscale and sagebrush with dense tamarack along the river.

Walker River courses generally south through the north half of the township, draining into the north end of Walker Lake which lies in the southerly portion of the township.
