CHAINS

Beginning at Monument No. 7 on the boundary of the City of Lovelock, Nevada, monumented with a nail in the center of a concrete post, 4 x 4 ins., firmly set, protruding 2 ins. above the ground, in a scattered mound of concrete. This monument was established by a man whose last name is King, in 1908, as shown on an unrecorded plat of survey of the Lovelock City Limits. This plat is in the City records, but its age and condition make legible reproduction by normal methods impossible. It has been locally accepted as the basis for defining property boundaries within the City of Lovelock for many years.

Monument No. 7 was used by Robert G. Leighton, Registered Professional Engineer No. 397, Nevada, in a 1960 survey for the Pershing Hospital, as shown on the plat of survey recorded in the Pershing County records in Map Case, Pocket 1, Folder 1, File No. 52297. It is also on an unrecorded plat of survey by Joseph W. Whittle, Registered Professional Engineer No. 2380, Nevada. This monument is locally recognized and is hereby accepted as the E. 1/16 sec. cor. of secs. 27 and 34.

At the corner point

Set an iron post, 28 ins. long, $2\frac{1}{2}$ ins. diam., 26 ins. in the ground, with brass cap mkd.

A power pole, 10 ins. diam., bears S. $45\frac{1}{4}$ ° W., 40 lks. dist., with nail driven at breast height.

An elm, 8 ins. diam., bears N. 65 $^3\!4^{\circ}$ W., $31^1\!_2$ 1ks. dist., mkd. E 1/16 S27 BT.

Set the original monument alongside the iron post.

This cor. falls in an irrigation canal, 15 ft. wide, 6 ft. deep, which drains westerly.

From this point a monument locally accepted as the cor. of secs. 26, 27, 34, and 35 bears S. 89° 21' E., 20.11 chs dist., monumented with a nail in a wooden stake driven in an iron pipe, 2 ins. diam., firmly set, 2 ins. below the ground surface, with a steel fence post, protruding 3 ft. above the ground, bearing S., 3 lks. dist. This monument was perpetuated by the Nevada State Highway Department as shown in field tablets on file in the records of the Department's Lovelock office.

Along the center of a nearly level irrigation canal which drains westerly.
