<p>CHAINS</p>	<p>Set an iron post, 28 ins. long, 2½ ins. diam., 22 ins. in the ground, with brass cap mkd.</p> <p style="text-align: center;">T38N T39N R52½E R53E S 1   S 31             S 6 CC T38N</p> <p style="text-align: center;">1981</p> <p>Deposit the original cornerstone and set a steel fence post, 5½ ft. long, alongside the iron post and raise a mound of stone, 3 ft. base, 2 ft. high, E. of cor.</p> <p>This corner is located in a fence, bearing N. and S.</p> <p>From this corner, a spring, 1 chain diam., course SW., bears S. 68° 04' W., 8.60 chs. dist.</p> <p>39.82 The cor. of Tps. 38 and 39 N., R. 52½ E., monumented with an iron post, 2½ ins. diam., firmly set and exposed 6 ins. above the ground, with brass cap marked as described in the field notes of the dependent resurvey of T. 39 N., R. 53 E., executed under Group Nos. 574 and 585.</p> <hr/> <p style="text-align: center;">DEPENDENT RESURVEY OF THE EAST BOUNDARY, T. 38 N., R. 52 E., MOUNT DIABLO MERIDIAN, NEVADA</p> <hr/> <p style="text-align: center;">Reestablishment of the Survey Executed by A. Deputy Surveyors, in 1871.</p> <hr/> <p>From the cor. of Tps. 37 and 38 N., R. 52 E., monumented with an iron post, 2½ ins. diam., firmly set and exposed 6 ins. above the ground, with brass cap marked as described in the field notes of the dependent resurvey of T. 37 N., R. 52 E., executed concurrently under this same group.</p> <p>N. 0° 37' E., along the E. bdy. of sec. 36.</p> <p>Over gently rolling land, covered with sagebrush and native grass.</p> <p>6.52 The closing cor. of Tps. 37 and 38 N., R. 52½ E., hereinafter described.</p> <p>10.50 Trail road, bears E. and W.</p> <p>20.00 Fence, bears ENE. and WSW.</p> <p>28.00 Coon Creek, 30 lks. wide, 1 ft. deep, drains W.</p> <p>39.73 Point for the ¼ sec. cor. of secs. 31 and 36, at proportionate distance; there is no remaining evidence of the original corner. This corner now refers to the ¼ sec. cor. of sec. 36 only.</p>
