From this same corner, the $\frac{1}{4}$ sec. cor. of secs. 9 and 16, monumented with an iron post, $2\frac{1}{2}$ ins. diam., firmly set showing 6 ins. above ground, with brass cap mkd. as described in the field notes of the independent resurvey of T. 17 S., R. 65 E., executed under Group No. 373, bears S. 0° 06.5' E.

From this same corner, the N $\frac{1}{4}$ sec. cor. of sec. 9, monumented with an iron post, $2\frac{1}{2}$ ins. diam., firmly set showing 12 ins. above ground, with brass cap mkd. as described in the field notes of the independent resurvey of T. 17 S., R. 65 E., executed under Group No. 373, bears N. 0° 06.5' W., 3.161 chs. dist. Hereafter, this cor.f will function as an amended monument.

The standard $\frac{1}{4}$ sec. cor. of sec. 32, T. 16 S., R. 65 E., monumented with an iron post, 1 in. diam., firmly set showing 8 ins. above ground, with brass cap mkd. as described in the field notes of the independent resurvey of T. 16 S., R. 65 E., executed under Group No. 237, bears S. 89 $^{\circ}$ 59.3 $^{\circ}$ W., 11.831 chs. dist. Hereafter, this cor. will function as an amended monument.

Add the marks "AM 1986" to the brass cap.

From the $\frac{1}{4}$ sec. cor. of secs. 7 and 8, monumented with an iron post, $2\frac{1}{2}$ ins. diam., firmly set in a mound of stone, with brass cap mkd. as described in the field notes of the independent resurvey of T. 17 S., R. 65 E., executed under Group No. 373.

N. 0° 03.3' W., bet. secs. 7 and 8.
