

DEPENDENT RESURVEY OF A PORTION OF
THE SUBDIVISIONAL LINES,
T. 17 S., R. 64 E., MDM, NEVADA

CHAINS

From which

The standard cor. of Tps. 16 S., Rs. 63 and 64 E., established in 1938, (now an amended monument), monumented with an iron post, 1 in. diam., firmly set showing 6 ins. above ground, with brass cap mkd. as described in the field notes of the dependent resurvey of a portion of the Fourth Standard Parallel South, through Range 63 East, executed concurrently under this same Group bears WEST, 14.08 chs. dist.

Point for the N $\frac{1}{4}$ sec. cor. of sec. 8 at the intersection with the Fourth Standard Parallel South and the N - S center line of sec. 8

Set a stainless steel post, 28 ins. long, 2 $\frac{1}{2}$ ins. diam., 24 ins. in the ground, with brass cap mkd.

Set a wooden post, 4 ins. square, 4 ft. long, alongside the stainless steel post.

From this corner, the standard cor. of secs. 31 and 32, T. 16 S., R. 64 E., monumented with a stainless steel post, 2 $\frac{1}{2}$ ins. diam., firmly set showing 4 ins. above ground, with brass cap mkd. as described in the field notes of the dependent resurvey of the Fourth Standard Parallel South, through Range 64 East, executed concurrently under this same Group, bears EAST, 9.76 chs. dist.

From this same corner, the $\frac{1}{4}$ sec. cor. of secs. 8 and 17, monumented with an iron post, 1 in. diam., firmly set showing 6 ins. above ground, with brass cap mkd. as described in the field notes of the independent resurvey of the subdivisional lines of T. 17 S., R. 64 E., executed under Group No. 237, bears S. 0° 03' E. Remark the brass cap to read as follows:

From this same corner, the N $\frac{1}{4}$ sec. cor. of sec. 8, monumented with an iron post, 1 in. diam., firmly set showing 6 ins. above ground, with brass cap mkd. as described in the field notes of the independent resurvey of the subdivisional lines of T. 17 S., R. 64 E., executed under Group No. 237, bears N. 0° 03' W., 5.36 chs. dist. Hereafter, this cor. will function as an amended monument.

Add the marks "AM 1987" to the brass cap.
