Brunt and W. H. Proctor, U.S. Deputy Surveyors, in 1881 and the resurvey executed by Cadastral Surveyor P. K. Russell in 1957.</p> <hr/> <p>From the standard cor. of Tp. 20 S., Rs. 58 and 59 E., monumented with an iron post 2½ ins. diam., firmly set, exposed 8 ins. above the ground, with brass cap mkd. as described in the field notes of T. 21 S., R. 59 E. executed under Group No. 362. Add the marks 1992 to the brass cap.</p> <p>S. 89° 26.2' W., on the S. bdy. of sec. 36.</p> <p>Over broken mountainous land, covered with shadscale and scattered grasses.</p>
7.024	<p>The closing cor. of Tp. 21 S., Rs. 58 and 59 E., identical with Angle Point No. 1, Parcel A, T. 21 S., R. 58 E., hereinafter described.</p>
33.123	<p>A rebar, $\frac{5}{8}$ in. diam., firmly set, exposed 2 ins. above ground, with aluminum cap mkd. RLS 2050, bears NORTH 0.004 chs. dist. This is a monument of no record and was not utilized in this survey</p>
33.146	<p>The E $\frac{1}{16}$ sec. cor. of sec. 1, identical with Angle Point No. 2, Parcel A, hereinafter described.</p>
53.272	<p>Point for the standard $\frac{1}{4}$ sec. cor. of sec. 36, at proportionate distance; falls in inaccessible area, there is no remaining evidence of the original corner.</p> <p>NOT MONUMENTED</p>
59.268	<p>The N $\frac{1}{4}$ sec. cor. of sec. 1, T. 21 S., R. 58 E. hereinafter described.</p>
69.50	<p>Summit of Calico Hills, ridge, bears SE. and NW.</p>
106.544	<p>The standard cor. of secs. 35 and 36, monumented with an iron post 2½ ins. diam., firmly set in a mound of stone, with brass cap mkd. as described in the field notes of the dependent resurvey executed under Group No. 362. Add the marks 1992 to the brass cap.</p> <hr/> <p>N. 89° 37.4' W., on the S. bdy. of sec. 35.</p> <p>Over rolling land, covered with creosote, shadscale and scattered grasses.</p>
4.968	<p>The closing cor. of secs. 1 and 2, T. 21 S., R. 58 E., hereinafter described.</p>
6.70	<p>Red Rock Scenic Drive, oiled, bears SE. and NNW. on curve.</p>
