From this corner, the closing cor. established in the 1943 survey, monumented with an iron post, 3 ins. diam., firmly set flush with the surface of the ground, with brass cap mkd. as described in the field notes of the dependent resurvey of T. 21 S., R. 62 E., executed under Group No. 336, bears N. 3°29.0' W., 0.085 chs. dist. Remove the present marks and add AM 1991 to the brass cap.

From this same corner, the original closing cor. remonumented in the 1943 survey, monumented with an iron post, 1 in. diam., firmly set and exposed 8 ins. above the ground, with brass cap mkd. as described in the field notes of the dependent resurvey of T. 21 S., R. 62 E., executed under Group No. 336, bears N. 0°53.2' W., 0.334 chs. dist.

From this same corner, the standard cor. of Tps. 20 S., Rs. 62 and 63 E., hereinbefore described, bears N. 89°45.3' E., 14.481 chs. dist.

From the cor. of secs. 7, 12, 13 and 18, on the E. bdy. of the Tp., monumented with an iron post, 2 ins. diam., firmly set in concrete slab, 8 ft. square and exposed 6 ins. above the ground, with brass cap mkd. as described in the field notes of the dependent resurvey of T. 21 S., R. 62 E., executed under Group No. 336. Add the marks 1991 to the brass cap.

N. 89°02.6' W., bet. secs. 12 and 13.

Over rolling land, through scattered creosote brush.

The $\frac{1}{4}$ sec. cor. of secs. 12 and 13, monumented with a PK nail and flasher, set flush on top of a concrete slab, 8 ft. square and exposed 6 ins. above the ground. A record found in Clark County, Nevada, File 55, Page 82 of Surveys, indicates this position is a remonumentation of the found 1943 monument. This is accepted as a careful and faithful perpetuation of the position of the 1943 corner.
