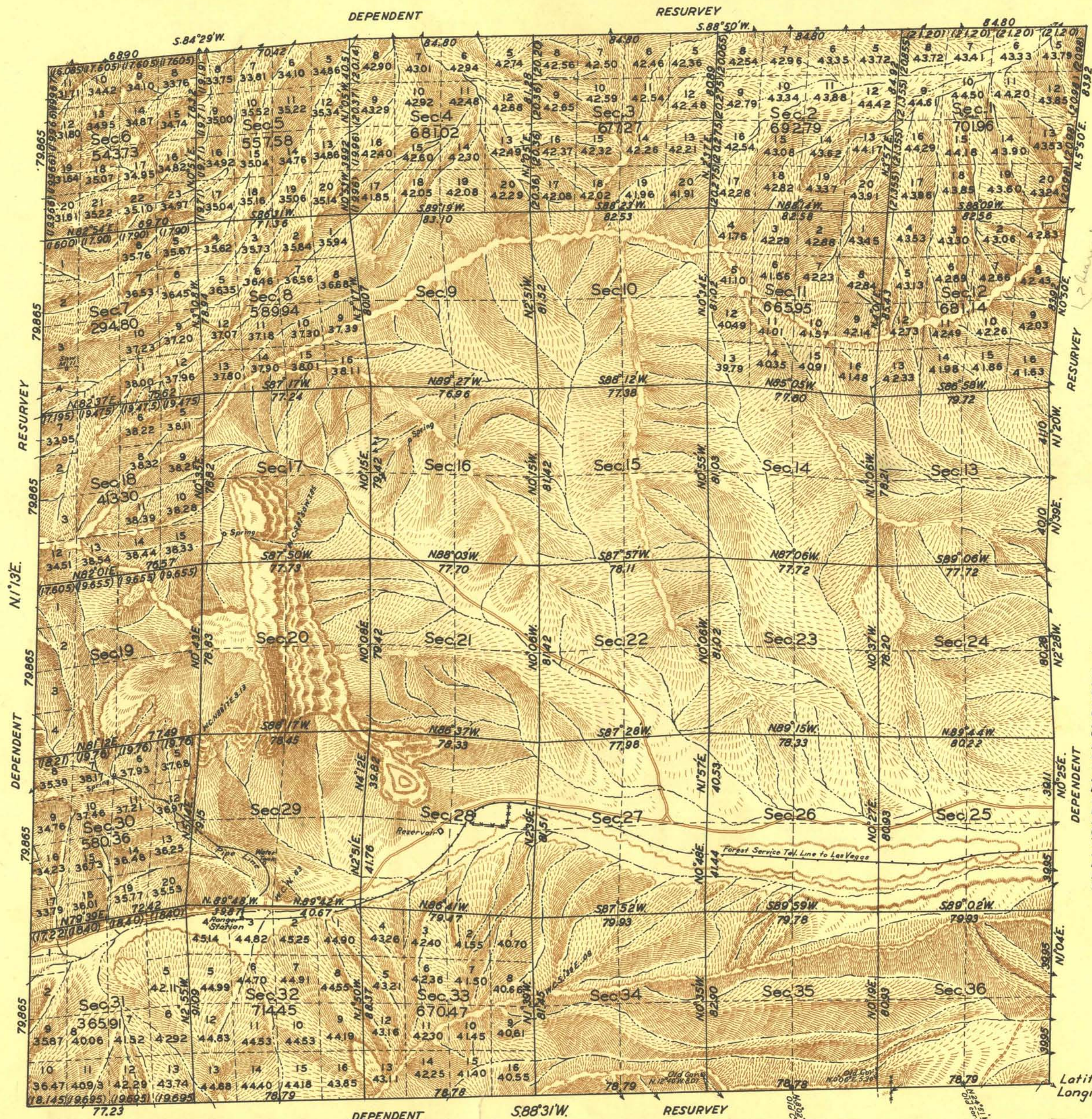

THIS RESURVEY WAS EXECUTED UNDER AUTHORITY OF THE COMMISSIONERS LETTER 1903247 "E" WHH DATED AUGUST 2, 1903. THE PLAT OF THE RESURVEY OF S. 9, S. 27, T. 40M, N. 24M, NEVADA DELINEATES RETRACEMENT AND REESTABLISHMENT OF THE LINES OF THE ORIGINAL SURVEY AS SHOWN UPON THE PLAT APPROVED OCTOBER 14, 1881, IN THEIR TRUE ORIGINAL POSITION ACCORDING TO THE BEST AVAILABLE EVIDENCE OF THE POSITION OF THE ORIGINAL CORNERS; ALL DIFFERENCES BETWEEN THE MEASUREMENTS SHOWN ON THE ORIGINAL PLAT AND THOSE DERIVED IN THE RETRACEMENT HAVE BEEN DISTRIBUTED PROPORTIONALLY BETWEEN ACCEPTED CORNERS IN ACCORDANCE WITH THE SURVEYING RULES. REFERENCES WILL BE MADE TO THE ORIGINAL PLAT FOR THE SHOWING OF AREAS AND MORE DETAILED DESCRIPTIONS EXCEPT THAT IN THE FOLLOWING SECTIONS, RECOMPUTED AREAS FOR PUBLIC LANDS UNDER THE RESURVEY ARE SHOWN AS INDICATED ON THIS PLAT: SECTIONS 1, 2, 3, 4, 5, 6, 7, 8, 11, 12, 18, 30, 31, 32 & 33.
